The Organisers, Dudley Canal Trust and Worcester-Birmingham & Droitwich Canals Society, would like to invite your Trade, Craft or Charity Stall to their bi-annual event at Parkhead Locks

Outside Trade Pitches are sized at 12ft x 12ft with a space for a vehicle behind your stand (this vehicle space is a non-trading area). The rear of your stand will be fenced off during the day, but with provision to be able to fence the front of your stand off during the Saturday night (we have security walking around all night). As the pitches are adjacent to each other, it is important to state beforehand if you are intending to encroach into the next bay. The charge for an additional bay will be the same as a 12ft x 12ft pitch.

 Charity Stall (minimum 12ft x 12ft) £20 day or £40 weekend
 Canal Society Stall (free if only displaying) or £20 day or £40 weekend
 Catering Stall by negotiation

All entries made on this form are correct at the time of entry. Any changes must be notified and agreed with the Organisers beforehand. This entry covers the stall named on this form only. No refunds will be made for cancellation or non-attendance.

The Organisers reserve the right to refuse any entry.

All exhibitors and their contractors must have public liability indemnity insurance to at least £5,000,000 (five million pounds) unless agreed in writing with the Organisers. (Note: If this condition is likely to cause a difficulty for any exhibitor, this should be discussed with the entries officer at the earliest opportunity to see whether any reduction in this requirement might be acceptable.)

All caravans and tents must comply with the conditions of the Organisers instructions issued during the event and those attending must carry third party liability insurance to a minimum of £1,000,000 (one million pounds).

The siting of the stall is at the absolute discretion of the Organisers and may be changed at any time. The Organisers reserve the right to move any stalls, caravans or tents prior to and/or during the gathering should the need arise.

The Organisers cannot be held responsible for any injury or damage to persons or property, however caused.

The Organisers' ruling on all matters is final.

Information on this form may in whole or part be recorded in a computer in accordance with current data protection legislation. All data recorded under your name may be inspected on application to the entries manager.

The Organisers warn all attendees of the dangers of Weil's Disease and other water borne infections but cannot be held responsible should any disease be contracted whilst attending or travelling to or from the event.
